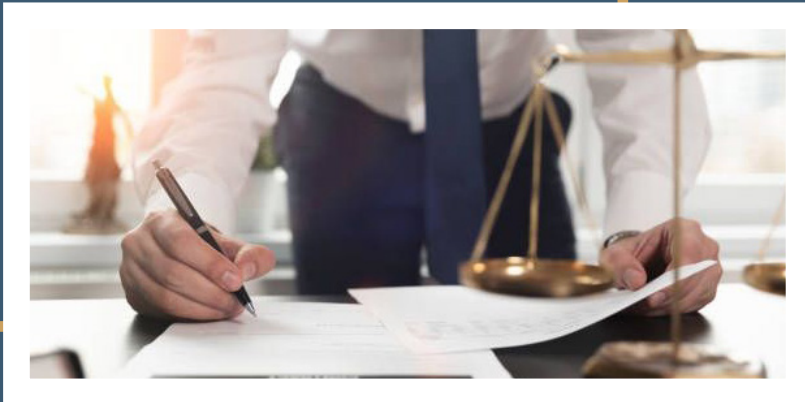
## Cases and Consultations:

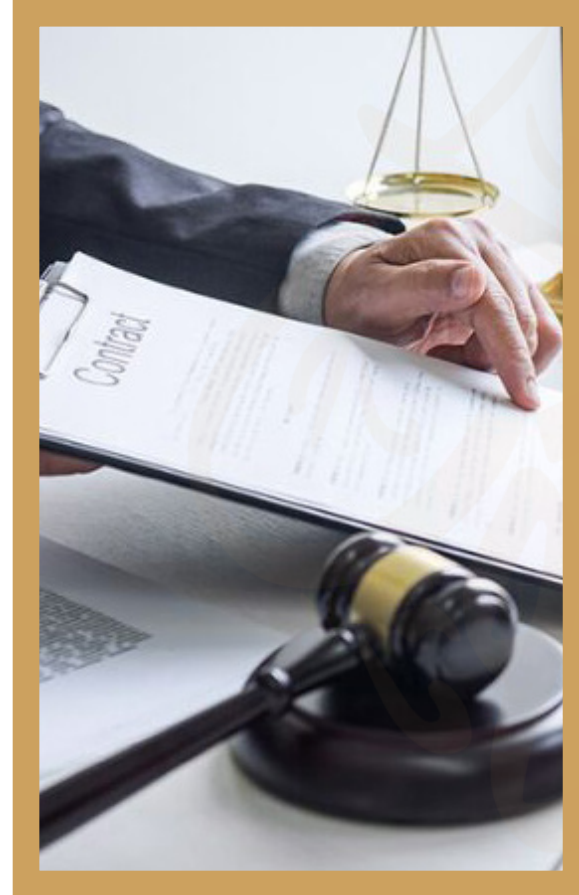

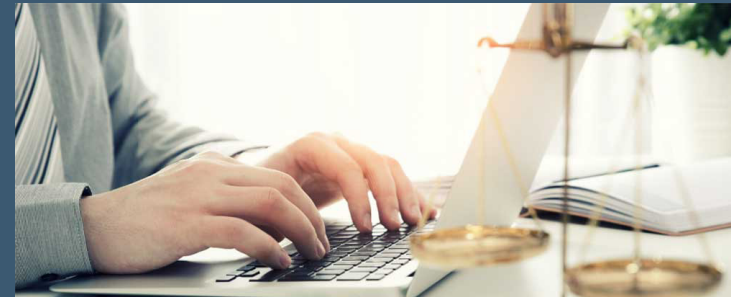
